CMC OFFERS FREE AND LOW-COST PRIVATE LESSONS, ENSEMBLE AND THEORY CLASSES, WORKSHOPS, AND COMMUNITY PERFORMANCES THROUGHOUT THE YEAR AND ADMINISTERS THE LARGEST TUITION-ASSISTANCE PROGRAM OF ITS KIND IN THE COUNTRY. CMC FEATURES STUDENTS, FACULTY, AND GUEST ARTISTS IN HUNDREDS OF CONCERTS EACH YEAR IN THE E.A. MICHELSON CONCERT HALL, A NEW RECITAL HALL, AND IN OFF-SITE VENUES THROUGHOUT SAN FRANCISCO. THE NEW RECITAL HALL AND SIX NEW CLASSROOMS ARE PART OF CMC'S EXPANDED MISSION DISTRICT CAMPUS, WHICH OPENED ON JANUARY 3, 2024. THE OFFICIAL RIBBON-CUTTING CEREMONY TOOK PLACE ON FEBRUARY 21, FEATURING A VISIT FROM SAN FRANCISCO MAYOR LONDON BREED, REMARKS FROM MANY LOCAL STAKEHOLDERS, AND STUDENT AND FACULTY PERFORMANCES. -- IN 2024, OVER 3,400 STUDENTS, AGES 1-95, BENEFITED FROM THE EXPERTISE OF 124 TEACHING ARTISTS ON TWO CAMPUSES AND IN OFF-SITE PARTNERSHIP PROGRAMS. THEIR AGE GROUPS WERE 1% 0-5, 32% 6-10, 24% 11-18, 13% 19-35, 9% 36-54, 12% 55-74, AND 7% 75-95. THOSE WHO REPORTED THEIR GENDERS WERE 54% FEMALE, 39% MALE, 3% NONBINARY OR GENDER NON-CONFORMING, 1% TRANSGENDER, AND 3% DECLINE TO STATE. PEOPLE FROM THESE COMMUNITIES, WOMEN, BIPOC AND LGBTQI PEOPLE SERVE ON CMC'S BOARD, FACULTY, AND STAFF. IN PARTICULAR, THE BLACK MUSIC STUDIES PROGRAM, NOW IN ITS FOURTH YEAR, HAS NEARLY DOUBLED THE NUMBER OF BLACK TEACHING ARTISTS EMPLOYED BY CMC. COMMUNITY MEMBERS ARE REGULARLY SOUGHT OUT FOR EXPERT ADVICE AND FEEDBACK. ALL OF THESE EFFORTS ARE FRAMED BY OUR ONGOING DIVERSITY, EQUITY, INCLUSION, AND BELONGING INITIATIVE WHICH IS TRANSFORMING CMC INTO A TRULY ANTI-BIASED ORGANIZATION.THE WIDE RANGE AND COMPLEXITY OF CMC'S WORK MEANS THAT, ON A LOCAL LEVEL, WE SEEK TO FORM MUTUALLY BENEFICIAL PARTNERSHIPS TO HELP MEET SPECIALIZED DEMANDS FOR ARTS EDUCATION. WE SHARE GOALS AND COLLABORATE WITH PARTNERS AS DIVERSE AS THE SAN FRANCISCO UNIFIED SCHOOL DISTRICT, THE SF ARTS COMMUNITY COLLABORATIVE, THE SAN FRANCISCO DEPARTMENT OF DISABILITY AND AGING SERVICES, THE COALITION OF AGENCIES SERVING THE ELDERLY, ACCIN LATINA, MISSION CULTURAL CENTER FOR LATINO ARTS, MISSION NEIGHBORHOOD CENTERS, JAMESTOWN COMMUNITY CENTER, YERBA BUENA GARDENS FESTIVAL, MUSEUM OF THE AFRICAN DIASPORA, AND JONES UNITED METHODIST CHURCH.
